The dispersion has a fine particle size with a narrow distribution curve. Snowtack SE 724G is alkylphenol ethoxylate (APE) free. The stabilizer is Polymeric.

All **Snowtacks** must be protected from freezing conditions. Care should be taken with handling procedures and equipment to avoid the formation of foam.
